## SOLID WASTE COLLECTION PRACTICES

Effective July 1, 2009

1. Tree limbs, hedge and shrubbery cutting, when not produced by a tree or landscape contractor, will be collected provided such brush is placed at the street edge with the large end of each limb toward the street for quick loading. **The collection of tree trimmings shall include noting more than four (4) inches in diameter and eight (8) feet in length. Tree trimmings larger than four (4) inches in diameter must be trimmed and cut into length of not more than thirty (30) inches.** Tree stumps, tree trunks and limbs produced by landscape workers, tree trimmers or contractors doing such work will not be hauled or removed by town trucks.
2. **Brush must be piled so that the butt ends are together and in the same direction, not to exceed four (4) feet in height. Disorganized piles will not be picked up.**
3. Leaves must be placed in clear plastic bags, except during the time that the vacuum leaf collection truck is in operation, from October 25<sup>th</sup> to January 10<sup>th</sup>. Leaves placed on gravel driveways or unpaved street must have plastic tarp under the pile. No tree limbs, shrubs or other materials shall be mixed with the leaves.
4. **Large trash items such as appliances, large furniture items (couches/loveseat, recliners/overstuffed chairs, bed frames, dressers, tables, etc.), mattresses and box springs, televisions, hot water heaters, etc. will be collected by the town. The property owner will be billed a fee of \$15.00 for each item collected by the town.**
5. Smaller trash items not accepted as garbage will be collected by the town at no charge. This includes items such as kitchen chairs, microwave ovens, computers, push lawnmowers, weed eaters, etc.
6. The property owner is responsible for disposal of the following items:
  - a) Hazardous materials of any kind
  - b) Building/Remodeling items (including but not limited to carpet, lumber, drywall, rocks, dirt, concrete, etc.
  - c) Batteries (large alkaline batteries and wet cell/lead acid batteries such as the kind found in cars, trucks and boats)
  - d) Vehicle parts of any kind, including tires.
7. All refuse must be placed in neat, compact piles, a separate pile for each different type of refuse. Brush, trimmings and hedge cuttings, leaves, wood, cardboard, paper and material must be placed in distinctly different piles. Any household whose refuse is not piled in the proper manner will be notified, in writing, by the public works director. Such notification will indicate what must be done to prepare the refuse for collection.
8. No collection shall be made from vacant lots.
9. **Storm damage will be handled on an as needed basis.**
