



## TRASH and SOLID WASTE COLLECTION PRACTICES

1. **Trash:** Republic Services provides trash collection for the Town of Ramseur. A trash container will be supplied to each residence and business within the corporate limits at a cost of \$17.00 per month. Residences are not allowed to waive this service or the fee. Businesses may contract their own dumpster service in lieu of a trash container at their own expense. As per Town Ordinance trash will not be allowed to accumulate at a residence or a business. **Up to two additional cans may be obtained for an additional monthly fee of \$17.00 per can by contacting Town Hall and completing the Additional Garbage Can Request Form.** Trash is collected each Friday morning and should be at the curb for collection before 6:00 a.m. and container pulled to the back of the residence or business after pick up. **Only waste which is placed in the provided container will be collected. It is prohibited for trash containers to be moved from one residence or one business to another.** Trash containers are the property of Republic Services and are on loan to Town of Ramseur and therefore are not the property of the resident or business owner. Fees are listed on Town of Ramseur Fee Schedule and are subject to change.
2. Tree limbs, hedge and shrubbery cuttings, when not produced by a tree or landscape contractor, will be collected provided such brush is placed at the street edge with the large end of each limb toward the street for quick loading. The collection of tree trimmings shall include nothing more than four (4) inches in diameter and eight (8) feet in length. Disorganized piles will not be picked up. Any household whose refuse is not piled in the proper manner will be notified, in writing, by the public works director. Such notification will indicate what must be done to prepare the refuse for collection.
3. Tree stumps, tree trunks and limbs produced by landscape workers, tree trimmers or contractors doing such work will not be hauled or removed by town trucks.
4. Leaves must be placed in clear plastic bags, except when the vacuum leaf truck is in operation, from October 25<sup>th</sup> to January 25<sup>th</sup>. During that time, leaves must be placed within 7 feet of the edge of the pavement. Leaves placed on gravel driveways or unpaved street must have plastic or a tarp under the pile. No tree limbs, shrubs or other materials shall be mixed with the leaves.
5. **Large trash items such as appliances, large furniture items (couches/loveseats, recliners/overstuffed chairs, bed frames, dressers, tables, etc.), mattresses and box springs, hot water heaters, etc. will be collected by the Town for a fee of \$25.00 per collection or \$100.00 per collection for commercial including apartments. This fee will be added to the monthly water bill.**
6. The property owner/tenant is responsible for disposal of the following items:
  - a. Hazardous materials of any kind
  - b. Building/Remodeling items, including but not limited to carpet, lumber, drywall, rocks, dirt, concrete, etc.
  - c. Batteries (large alkaline batteries and wet cell/lead acid batteries such as the kind found in cars, trucks, and boats)
  - d. Vehicle parts of any kind, including tires
  - e. Electronics of any kind
7. No collection shall be made from vacant properties.
8. Storm damage will be handled on an as needed basis.
